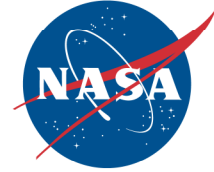

Subject: Publishing Agreement for Peter A. Parker, Ajay Koshti, Michael W. Suits, James L. Walker and William H. Prosser

This concerns the Publishing Agreement (or “Agreement”) of the International Committee on Aeronautical Fatigue and Structural Integrity (or “Publisher”) representing your terms and conditions for publication of a contribution by NASA employees, Peter A. Parker, Ajay Koshti, Michael W. Suits, James L. Walker and William H. Prosser (or “NASA Authors”), of NASA Langley Research Center, Johnson Space Flight Center and NASA Marshall Spaceflight Center to ICAF 2023. The NASA Authors' contributions are a publication/presentation titled “NASA NDE Fracture Critical Detectable Flaw Sizes History and Methodology” (said contribution being referred to herein as the “Work”). We regret that the NASA Authors are prevented by U.S. Government regulations from executing said Agreement. This letter is provided in lieu of the Agreement and we trust that it will suffice to permit publication of the Work to take place. Should online submittal of the work be required, the NASA Authors, and anyone acting on their behalf, will be allowed to check on-line boxes or radio buttons only for the purpose of facilitating the upload of the Work. However, the copyright permission provided to the Publisher for the Work will be governed only by the terms and conditions contained in this letter.

The Work is co-authored by the NASA Authors and non-U.S. Government authors David S. Forsyth. U.S. copyright protection does not attach to separable portions of a Work authored solely by U.S. Government employees as part of their official duties. The U.S. Government is the owner of foreign copyrights in such separable portions of the Work and is a joint owner (with the non-U.S. Government author) of U.S. and foreign copyrights that may be asserted in inseparable portions the Work. The U.S. Government retains the right to use, reproduce, distribute, create derivative works, perform and display portions of the Work authored solely or co-authored by a U.S. Government employee (referred to herein as “U.S. GOVERNMENT

RIGHTS”).

Subject to the aforementioned reservation of U.S. GOVERNMENT RIGHTS, Publisher is granted permission to reproduce, publish, and distribute the Work in any form, language, or manner, now or hereafter known or developed, throughout the world, and to authorize others to do so on its behalf.

In accordance with Title 18 of the United States Code § 209, U.S. Government employees may not accept compensation for their government service from any source other than the U.S. Government. Thus, the NASA Authors may not accept any royalties resulting from publication of the Work or arising from the aforementioned permissions granted to Publisher.

As acknowledged below, the NASA Author has represented to NASA that, to the best of his knowledge, he is an original author of the Work; the Work has not heretofore been published in book form; the Work contains nothing of a libelous, injurious, or unlawful nature; the Work does not infringe upon any existing copyright, proprietary right, or other right of a third party; and all clearance permissions, if necessary, to use materials of third parties have been obtained.

This letter and the permission granted herein are subject to the following conditions:

1. The Work shall not be used in any manner that would suggest or imply endorsement by NASA or any NASA employee of any commercial product, service or activity;
2. Publication by Publisher in no way limits U.S. GOVERNMENT RIGHTS in the Work;
3. The U.S. Government or the author retain all proprietary rights, such as patent and trademark rights and rights to any process or procedure, described in the Work;
4. Publisher agrees to furnish the NASA Author, on behalf of the U.S. Government, at least one (1) copy of the Work free of cost;
5. Any transmission of the Work must be in conformance with United States export control laws; and
6. Neither NASA nor the U.S. Government shall be liable to Publisher for any actions or failure to act on the part of the employee-author in connection with the Work, or publication thereof.

This letter and the permission granted herein only address the U.S. Government employee's contributions to the Work. Neither NASA nor the U.S. Government is obligated to obtain any permissions/assignments from non-U.S. Government authors.
